Presentation: Ann Thomas and Rhonda Parks - The Children's Place	<b>G.</b> Thompson	G.Thompson introduced Ann Thomas (President and CEO of The Children's Place) and Rhonda Parks (Parent Educator) to speak about family support services at The Children's Place. The Children's Place specializes in working with children under the age of eight that have experienced life's biggest hurts (abuse/neglect/domestic violence/traumatic experiences). The Children's Place emphasizes that when they're working with young children and doing early intervention, part of the critical work is working with the 'BIGS' (the caregivers/parents) and helping them understand their parenting strategies. If not working with adults as well as the children, then the sustainability and the long-term impact is compromised. R.Parks shared that she has three personal goals that she wants to accomplish with the parents: build rapport and trust with the parent, assisting parent in identifying their own goal, and working with parent to meet that goal and for them to feel good about it. The Children's Place provides Family Support Services, which "helps families build stronger, happier, and more positive relationships with their children Caregivers become more confident and competent in their parenting skills, and children and families thrive." Cultural Competence Advisory Council (CCAC) Update	<b>G.Thompson</b>	G.Thompson reported that the CCAC met on Wednesday, 23-Mar-2022. G.Thompson expressed his concerns to the CCAC regarding how social determinants of health are dealt with within health care; that the true reasons for identifying social determinants of health are lost. As a provider within the community, the intention is that providers are trying to find persons that have their health impacted due to having unstable housing, not having food on the table, having mental health challenges, having their physical health threatened, et cetera. Adding value-based pay for numbers of patients identified with social determinants of health will perhaps lead providers to inflate the numbers or skew the findings rather than identify the true number of patients struggling with SDOH. Work continues on the Star-Rating System being rolled out. The next CCAC meeting will be on Wednesday, 27-April at the CMHF office.			
Value-Based Payment (VBP) Committee Update	<b>G.Thompson</b>	Integrus Health Group's Tomas Moran and Johanna Ferman presented the year 2021 raw and final scores for providers within the value-based payment initiative. Integrus Health Group is working with the CMHF to create a value-based payment system, which is going from a fee-for-service model (where providers are paid on units of service) into a hybrid method (which includes payment for value). The CMHF has two groups of agencies (two cohorts) that have been transforming into the value-based payment process. In years 1 and 2, provider training is conducted pertaining to the agency's culture and information management skill sets, and there is an incentive reward for participating and completing a set of concrete steps (this also allows the CMHF to collect baseline information about provider's internal processes). In Year 3 and beyond, providers are given an incentive reward for their success in improvement activities. Value within the provider agencies is measured and rewarded across four "domains": Access to care, Outcomes of care, Client's perspective, and Staff's perspective. The CMHF will create and present meaningful dashboards, which will contain key performance indicators (KPI's) from the CMHF provider agencies: meaningful meaning that "each indicator must contain information that is believed to be accurate and actionable" as well as that "each indicator is believed to be important as it relates to the organization's mission both from the perspective of the Agency and of the CMHF." The work the CMHF is doing with all of the agencies is to grow the key performance indicators organically rather than to dictate them.  J.Ferman noted that these incentive payments are not cumulative funding, but instead start fresh each year.	information
